



VISA FOR THE FOLLOWING FAMILY MEMBERS OF CITIZENS OF THE UNION
(STAYS UP TO 90 DAYS IN A PERIOD OF 180 DAYS)

- a) The spouse over 18 years old (provided that there has been no marriage annulment or divorce).*
b) The unmarried partner over 18 years old whose relationship with the citizen of the Union must be duly registered in the registry of the Union country (provided that the registry has not been cancelled).
c) The unmarried foreign partner over 18 years old who maintains a duly proven stable relationship with the citizen of the Union.

Please Note:

- Since the Embassy of Spain will not return the documents submitted, all of the above must be produced in **original** and **photocopy** with a translation into English, French or Spanish (sworn translator).

ATTENTION:

- The foregoing is not an exhaustive list of required documents. The Embassy of Spain may ask the applicant to provide any other additional information deemed necessary as well as it may call the applicant for an interview.
- It is important to mention that the presentation and processing of an application do not guarantee the delivery of the requested visa.
- Please be advised that the possession of a valid Schengen visa does not grant an irrevocable right of entry to or temporary stay in the territory of a Schengen member states. You may also be requested to present other evidence upon entry at the border post.
- Applicants may leave the passport at BLS office or retain it during the processing of the application. If the visa is approved, it will only be delivered once the applicant hands his passport back to the Embassy.
