



**INTERNATIONAL TELECOMMUTING RESIDENCE VISA (NOMAD VISA) AND FAMILY MEMBERS OF THE NOMAD**

**Note: ONLY APPLIES FOR THOSE WHO HAVE RECEIVED A RESIDENCE APPROVAL FROM THE SPANISH AUTHORITIES**

**Visa for non-EU foreigners to carry out an employment or professional activity remotely for companies located outside Spanish territory, through the EXCLUSIVE USE of IT, telematic, and telecommunication means and systems. Applicants must be qualified professionals who can prove that they are graduates or postgraduates from universities and business schools of recognized prestige or have at least three years of professional experience.**

**The following family members of a nomad may apply for a visa: the spouse or unmarried partner, children and adult children who are financially dependent on the nomad and who have not created a family unit of their own and relatives in the ascending line in the nomad's care.**

<b><u>Criminal record certificate</u></b> ("SEJEL AADLEH / LA HOKM AALE") issued by the authorities <b><u>of the country of origin and all countries where the applicants have resided during the last 2 years</u></b> and where it is shown that the person has not been sentenced for offences included in the Spanish Penal Code *.  <u>It has to be legalized by the Ministry of Foreign Affairs</u> of the country that has issued the document. **All documents written in a different language from Spanish have to be handed with a translation into Spanish by a juror translator.**

**\*The originals and the copies of all the documents must be handed.**

If needed for the assessment regarding the application, the Embassy may ask the applicant to submit any documents or additional data and to call the applicant for an interview.

**The legal period for reaching a decision is minimum 10 days as of the day after the submission date of the application**, but this period may be extended when an interview or additional documents are requested.

**Once the visa is approved**, the applicant has a **maximum of 1 month to retrieve the visa in person**. Otherwise, the Embassy will consider that the applicant has renounced the right to get the visa and the application will be filed.

Applicants may leave the passport at BLS office or retain it during the processing of the application. If the visa is approved, it will only be delivered once the applicant hands his passport back to the Embassy.
